 - e. All students for whom English is not a first language must submit scores from the Test of English as a Foreign Language (TOEFL). Code: 3369

 - f. A photocopy of your teacher's license(s) and a passing score on the Massachusetts Test of Educator Licensure (MTEL) Communication and Literacy Test, if applicable.

Applicable to Arts and Learning candidates only: include documentation of artistic involvement/skill, i.e. portfolio, performance history, or written statement explaining artistic interest and involvement. An admission interview is required of all candidates; please call Graduate and Professional Studies at (978) 232-2198 to make arrangements.
